












Requirements in El Salvador

The following cryptolicenses are available in El Salvador:

1.A BSP License is required for companies that provide various Bitcoin-related services, such as exchanging Bitcoins for fiat money, making payments in Bitcoins, or storing Bitcoins on behalf of clients. Under the Bitcoin Act, the issuance of a BSP license is handled by the BCR. 2.A DASP License is required for companies that provide a variety of services related to other cryptocurrencies. Under the DAI Law, registration of service providers is handled by the CNAD.





Company incorporation

- Minimum of 2 shareholders (Can be individuals or legal entities)
- Certified Passport copies of all shareholders and directors
- Proof of Address from all directors and shareholders
- Certified Power of attorney
- Share capital of \$2,000 (The Law allows the granting of the respective Deed by paying only 5% of the minimum capital stock with the amount of \$100)

License application

The main requirements for license application are the following

- Proove the ability to offer digital asset services
- Provide a list of the digital assets you plan to sell or trade
- Provide a detail of the company's organizational structure, such as, but not
- limited to, name, positions and specific functions
- Demonstrate that it has a coherent and efficient customer service system, corresponding to the nature of the service to be provided
- Provide Money Laundering Prevention Manuals and Policies related to cyberse-curity
- Each year, an annual fee must be paid for the renewal of such registration during the first half of each year
- Technological platform and IT systems
- AML Officer (Not obligatory to be a local)





Stage 1/2 week:

Collection of initial documents

- Company name you wish to have
- Certified Passport copies of all shareholders (at least 2)
- and directors
- Proof of Address from all directors and shareholders
- Certified Power of Attorney
- Business description
- At least 1-2 pages

Stage 2 / 2.5-5 months:

Company formation and licensing

- Company formation
- Preparation of the corporate documents
- Preparation of the license application documents
- Submission of license application to The National
- Commission for Digital Assets ("NCDA")





Stage 3 / 10-12 weeks:

Registration with public authorities

• Once the company registration is approved, it is necessary to apply to the Ministry of Finance, the Salvadoran Social Security Institute and the Ministry of Labor to register the company with these authorities. You will have 15 days after the company registration to register with the Ministry of Finance to obtain the Taxpayer Registration Number and Tax Identification Number

Stage 4 / up to 2 month:

Preliminary actions and obtaining a license Steps required to obtaining a DASP license in El Salvador:

- Documentation preparation
- Appointment of Certified Head of Compliance and a Deputy Head of Compliance, both positions must be occupied by people living permanently in El Salvador
- Applicant must fill out pre-registration form with information and documents related to applicant and area in which he wishes to operate
- CNAD`s assessment
- Submission of additional information by the applicant
- CNAD`s second evaluation
- Payment of a registration fee
